### **BASIC PACKAGE - \$500**

- Initial half-hour conference call to determine the nature of your business and any issues unique to you.
- Attorney will read through any existing terms and conditions, bills of lading, warehouse receipts, export compliance policies, template contracts (such as broker-carrier
  agreements) or similar documents up to one hour.
- Follow up half-hour conference call to discuss findings based on review of documents and suggested plan for addressing any opportunities for risk mitigation.
